SIVUMELWANO LESIPHAKANYISIWE

Tinkampani letisifupha, i-African Rainbow Minerals, i-Anglo American SA, i-AngloGold i-Shanti, i-Gold Fields, i-Harmony, i-Sibanye-Stillwater naletinye letibhalise kuto ("tinkampani tetimayini tegolide letingenenele") tifiki kusivumelwane lesibophwa negekwemtsetso kuhokhela sincepheteliso kubasebenti basemayini yegolide labafaneleki kanye nalabo bebabondli balabo basebenti basemayini laseboshona. Lesivumelwane lesiphakanyisiwe sitawulungisa ficolonkhokhelo kuleto tinkampani temayini yegolide letingenenele kusuka kusinylatselo semtsetso lesabekwa embi kwenkantolo Lesetulo ngeku:

- limala nekushona lokwatfolwa tisebenti tasemayini ngekungenwa isilicosis neTB ngesikhatsi sekusebenta kwabo etimayini letitsite tegolide eNingizimu Afrika, ne
- limala nekushonelwa lokwatfolwa ngulabo bebabondli betisebenti tasemayini tasemayini letashona ngalefio.

Uma lesivumelwane samukelwe kantsi futsi sekuhlangabetwane nato tonkhe letinye timo, Sikhwana lesibitwa i-Tshiamiso Trust sitawusungulu kantsi sitawuba khona iminyaka lokungenani leli-13 sisebeta.

Onkhe emalunga elicembu, ngaphandle kwalabo labakhetsa kuphuma kulesivumelwano, bona batawfumela sicelonkhokhelo ku Tshiamiso Trust kuhokhela sincepheteliso semali.

Bafakitelo labafanelekle batawutfolia imali letokhokhwa kanye lesemkhatsini wetinkulungwane leti R10 000 na R250 000, kuye ngesimo kanye nebumatima besifa. Kuletiyhe timo letingenhla, lesamba singenysuwa siyofika ku R500 000. Umfakisicelo lofanelikeli ngumruntu lolilunga lanoma ngabe nguliphi licembu abe angulohambisana netidzingo teTshiamiso Trust kufola sincepheteliso semali.
